EXPECTATIONS AND PROCEDURES FOR RELIGIOUS EXEMPTIONS

Guidance Teaching, Chaplaincy Team Leader, Support Services Staff:

Students registering in a secondary school in the Simcoe Muskoka Catholic District School Board will be required to register for one religion course in each year of attendance.

Registration forms will show religion as a compulsory course in each of the four years. Registration forms will not be considered completed until a religion course has been selected.

If questioned about this requirement, personnel should be directed to respond that the Simcoe Muskoka Catholic District School Board requires all registered students to enroll in one religion course in each year of attendance. Students enrolled in a Catholic school are expected to participate fully in the faith life of the school and this includes religion courses and other related activities such as liturgies, retreats and prayer services. Parents or students 18 years of age should be informed that registration forms will not be processed without the selection of a religion course.

Office and clerical staff and guidance department personnel should direct any person or parent who does not wish to comply with this expectation to make an appointment with the principal. The registration form should be set aside until such time as a religion course has been selected.

If parents or students 18 years of age do not wish to comply, they should be directed to make an appointment with the principal.

ENQUIRY PROCESS

School:

- A. Principal to meet and discuss with Guidance, Teaching, Chaplaincy Team Leader, Support Services, etc. and direct them to refer every exemption enquiry from a student and/or their parent(s)/guardian(s) to the Principal (or VP in their absence) with a formal request in writing regarding their intentions.
- B. In the interim, Guidance Counsellors will:
 - 1. Schedule the appropriate Religion Course in the students' timetable;
 - 2. Once all students with a Religion Course have had their timetable conflicts resolved, students with an approved religious exemption will be removed from their Religion Course;
 - 3. These students will meet with their Guidance Counsellor to have their timetable adjusted with any available courses scheduled within that period.

Note: PRIOR to any change request, it is our practice that all students must attend the course that was originally scheduled into their timetable.

Principal:

when the student with their parent(s)/guardian(s) makes an appointment to discuss the exemption lest with the Principal; the conversation should include the following discussion points:
The Simcoe Muskoka Catholic District School Board expects that all students registered in a Catholic high school will enroll in one religion course for each year of attendance and participate in all faith related events in the course of a school year.
Catholic schools provide students with an education that includes emotional, physical, intellectual and spiritual growth.
Students in Catholic high schools are required to meet the expectations of the Ontario Catholic Graduate Expectations including religious instruction and courses.
Exclusion from faith formation is not in keeping with the expectations of students who graduate from Catholic high schools.
Catholic schools promote inclusion and non-Catholic students are not expected to exclude themselves from the core faith programme and other activities related to the faith life of the school.
Curriculum in all subject areas is infused with the beliefs and tenets of the Catholic faith.
Religion courses are but one aspect of the faith formation, all students are expected to participate fully in all religious activities in the school community including masses, retreats and paraliturgies.
Catholic schools provide students with a comprehensive religion programme that will influence and mold their lives into the future.

☐ Content of Religion Courses:

Grade Nine: focuses on the student as an individual and examines the challenges a teenager faces including peer influences and relationships within the context of Catholic teachings.

Grade Ten: Christ and the Church, examines the structure of the Church, the rituals and the meaning behind the various aspects of the liturgy.

Grade Eleven: World Religion, offers a look at other faiths and their components.

Grade Twelve: deals with an array of topics of morality and social justice such as euthanasia, abortion, invitro fertilization, capital punishment, cloning, stem cell research within the context of Catholic teachings.

Registration form should be presented and religion courses selected. If parent does not select course, he or she should be informed that the student will not be registered in the school.

If parent raises the issue of religion exemption, expectation should be restated (all students are expected to enroll in one religion course for each year of attendance). If parent asks for next recourse, they should be provided with a Secondary Religious Exemption Request Application and directed to the Superintendent of Education.

Superintendent:


Superintendent should confirm prior to meeting with parent that a meeting has been conducted with the principal.

Superintendent will review the content of the parent meeting with the principal.

Superintendent should review the expectations for attendance in a secondary school in the Simcoe Muskoka Catholic District School Board.

Superintendent should further question the choosing of a Catholic school if parent or student is not willing to enroll in religion courses and/or faith life of the school.

If parent is still not willing to comply, the Superintendent may consider the application for exemption received from the parent or student.
