You may have heard or read this story in the news. For a little background, the graphic novel in question, Drama, by Raina Telgemeier, was housed in a number of our elementary school learning commons. It came to our attention when a parent of a Grade 3 student contacted us regarding his concerns with the mature content in the book when his daughter brought the book home. Upon investigating, we decided to remove the book from our elementary libraries and send it to our intermediate/secondary schools. The book is rated by Scholastic as appropriate for "middle school" students (ages 10-14). With most of our elementary learning commons staffed part-time, we felt it was appropriate to house the books with our intermediate school grades.

Clearly someone from or connected to our elementary learning commons staff took issue with the decision, and has shared e-mails from Rob Long with the media. We will review with staff the appropriate channels to pursue when there are concerns with decisions made. If you are approached by the media concerning this matter, feel free to direct them to Mardi. If you have any questions or concerns about our decision, I would be happy to discuss with you.

Before I begin on explaining myself I'd like to provide you with some facts about myself and what it is that I do.
committee. I have been an active member for the last 14 years and have worked vigorously to ensure that Ottawa is and will remain an inclusive city. I also am a very big advocate for Youth and LGBTQ2 persons and have demonstrated that through my volunteering and assisting with clothing drives and food drives for YSB. So you could say this has put a very large dent in my trust with the OCSB.

My daughter This year she walked along side with me at the Ottawa Pride parade. I have done everything I have could to teach her that some boys like boys, some girls like girls, some persons like whoever they want and some persons choose to be with just themselves. Whatever that person decides they want in a relationship then it's their choice. Everyone deserves to be happy!!

I'd like to provide you with some information in regards to LGBTQ2 youth;
$24 \%$ of homeless youth in Ottawa identify as LGBTQ2

- $33 \%$ of LGB youth have attempted suicide in comparison to $7 \%$ of youth in general (Saewyc 2007).
- Over half of GLB students ( $47 \%$ of GB males and $73 \%$ of LB females) have thought about suicide (Eisenberg \& Resnick, 2006).
- In 2010, $47 \%$ of trans youth in Ontario had thought about suicide and $19 \%$ had attempted suicide in the preceding year (Scanlon, Travers, Coleman, Bauer, \& Boyce, 2010).
- LGBTQ youth are 4 times more likely to attempt suicide than their heterosexual peers (Massachusetts Department of Education, 2009).
- Adolescent youth who have been rejected by their families for being LGB are over 8 times more likely to attempt suicide than their heterosexual peers (Ryan, Huebner, Diaz, \& Sanchez, 2009).
- A study in Manitoba and Northwestern Ontario revealed that 28\% of transgender and Two Spirit people had attempted suicide at least once (Taylor, 2006).
- Both victims and perpetrators of bullying are at a higher risk for suicide than their peers. Children who are both victims and perpetrators of bullying are at the highest risk (Kim \& Leventhal, 2008; "Suicide and bullying: Issue brief" 2011).
- While suicide is never the result of one cause, bullying can have a long-lasting effect on suicide risk and mental health. The relationship between bullying and suicide is stronger for lesbian, gay and bisexual youth than for their heterosexual peers (Kim \& Leventhal, 2008):
- $68 \%$ of trans students, $55 \%$ of LB students and $42 \%$ of GB students reported being verbally harassed about their perceived gender identity or sexual orientation.
- $20 \%$ of LGBTQ students reported being physically harassed or assaulted about their perceived gender identity or sexual orientation.
- $49 \%$ of trans students, $33 \%$ of lesbian students and $40 \%$ of gay male students have experienced sexual harassment in school in the last year (Taylor et al. 2011).

Some children can't be themselves at home. Be a safe space. Making these resources readily available, having a rainbow sticker, having contact information for YSB, CHEO, etc available for these children. This digs deeper then a graphic novel.

I have purchased a copy of Drama for ince she has asked for it, and I have encouraged her to take it to school with her to read with her friends. Do not seize this book from my child. Do not make comments about this book to her. She is an inclusive child who believes that every person; male, female, non binary is perfect the way they are and they do not need people to tell them how to live their lives.

1 ask that you please return these books to the shelves of your library. It may save a child's life one day.
